QUALIFICATION (As on 22.12.2023)

a) For Medical Candidates:

A medical qualification (MBBS) included in the I or II schedule or Part II of the third schedule to the Indian Medical Council Act of 1956 (Persons possessing qualifications included in Part II or third schedule should also fulfill the conditions specified in section 13 (3) of the Act. Individual must have completed 1 year of compulsory internship from MCI/NMC recognized institute on or before 22.12.2023.

b) For Non-Medical Candidates:

Postgraduate qualification e.g. Master's degree in the concerned Medical Specialty. The degree must have been obtained on or before 22.12.2023.

- a) For filling up of application on the date of walk-in interview, the candidates have to bring the following documents (original and one set of self-attested copies) which also needs to be produced at the time of walk-in interview:-

- Internship Completion Certificate
- NMC/State Registration Certificate
- Experience Certificate, if any
- NOC from present employer (applicable for those working in Govt./Pvt. organization)
- Any other relevant documents (viz. Research Work, Publication etc.)
- For Non Medical Candidates: Master's Degree in concerned medical speciality

REASONS FOR REJECTION/CANCELLATION OF APPLICATION:

APPLICATION/CANDIDATURE OF APPLICANTS IS LIABLE TO BE CANCELLED/ REJECTED IN THE EVENT OF ALL OR ANY OF THE FOLLOWING:

- Applications being incomplete.
- ii. Any variation in the Signatures.
 - All the SIGNATUREs in FULL (NOT IN SHORT) done on the Application Form and also on other Documents must be the same.
- iii. Non-payment of application fees through Demand Draft, if not otherwise exempted.
- iv. Fee not paid as per instructions.
- v. Under aged/over aged candidates.
- Failure to bring (in original) all relevant Certificates/Documents issued by the competent authority, along with self-attested legible copies in support of the information given in their Application Forms about their Educational Qualifications; Experiences; Percentage of Marks obtained; Proof of Age at the time of Walk-in Interview and/or verification of document.
- vii. Not having the requisite Educational Qualification/Experience/
- viii. Incorrect information or misrepresentation or suppression of material facts.

ACTION AGAINST CANDIDATES FOUND GUILTY OF MISCONDUCT:

- (A) Candidates are warned that they should not furnish any particulars that are false or suppress any material information while filling in the application form.
