9. SELECTION PROCESS:

- a) Written test (MCQ based) will be held for selection to the advertised posts of Senior Residents.
- b) Total Number of questions will be 80, carrying one marks each. There will be no negative marking.
- c) Written test will be held on **15.03.2023 at AIIMS PATNA only.** Result of the written examination will be declared on same day on AIIMS, Patna website (www.aiimspatna.edu.in).
- d) Qualifying marks for written test will be as under: UR: 50 % OBC-NCL/EWS: 45 % SC/ST: 40
- e) The successful candidates {maximum three (03) times of seats in each speciality} will be called for the personal interview to be conducted from 16.03.2023 onwards. Total marks of interview will be of 20 Marks.
- f) Final Selection list will be declared on the combined marks of written and Interview marks.
- g) While every effort will be made to intimate the candidates regarding Exam/Interview schedule at the earliest, the responsibility lies with the candidate to check for the same on the institute website. All Candidates must provide phone numbers and E-mail for faster communication.
