

### 1. QUALIFICATION (AS ON DATE: 24.11.2023)

- (i) The candidates should have passed MBBS (including completion of Internship) from the MCI/NMC recognized Institute.
- (ii) NMC/MCI/State Registration is mandatory to be produced before joining, if selected

### 2. AGE LIMIT (AS ON 24.11.2023):

For eligibility to apply for these posts, upper age limit will be 37 years. Age limit relaxation for SC/ST candidate up to a maximum period of 5 years and for OBC candidate up to a maximum period of 3 years.

In the case of Orthopedic/ Physical handicapped (OPH) candidates, age limit is relax able up to maximum period of 05 years for General Category, 08 years for OBC category and 10 years for SC/ST candidates.

### 4. APPLICATION PROCESS:

- A) For filling up of application on the date of the walk-in interview the candidates have to bring the following documents (Original and one set of self-attested copies) which also need to be produced at the time of the walk-in interview:
  - Recent passport-size photograph of candidate
    - Face clearly visible
    - The picture should be in color against a light colored preferably white background.
    - Caps, hats, and dark glasses are not acceptable. Religious headwear is allowed but it must not cover your face.
  - Demand draft I original (if applicable)
  - Aadhar Card
  - Date of birth/SSC/HSSC pass certificate (mentioning date of birth)
  - MBBS degree certificate
  - Internship completion certificate
  - UG NMC/ State registration certificate
  - Category/PwBD certificate (if the seat is claimed in reserved category)
  - Experience certificate, if any
  - NOC from present employer (applicable for those working in Govt./Pvt organization)
  - Any other relevant documents (viz research work, publications etc.)
  - B) Payment of application fees by any other mode will not be accepted. The decision of the Executive Director, AIIMS Patna in this regard shall be final and binding.

### 5. RESERVATION:

Reservation for SC/ST/OBC/EWS/PwBD shall be applicable as per Govt. of India rules.

- OBC Candidate's eligibility will be based on the caste(s) borne in the Central list of Government of India. OBC Certificate should not be older than one year as on the last date of application. OBC candidate(s) should not belong to Creamy Layer and their sub-caste should be matched with the entries in Central List of OBC, failing which their candidature will not be considered under OBC reserved category post(s).
- For SC/ST Candidates Certificate should be issued by rank of Tehsildar or above in standard format of Central Government.
- **PwBD Candidates** The disability certificate should be signed by duly constituted and authorized Medical Board of the State or Central Govt. Hospitals/Institutions & countersigned by Medical Superintendent or equivalent. The constitution of the Medical Board will be of one consultant each from disciplines of Orthopedics, Physical Medicine & Rehabilitation and Surgery.

### RESERVATION FOR ECONOMICALLY WEAKER SECTION (EWS) :

The vacancies advertised under EWS Category are as per the instructions issued by DoPT, Ministry of Personnel, Public Grievances & Pension, Govt. of India, vide OM. No. 36039/1/2019-Estt (Res), dated 31.01.2019. Application under EWS category will be considered subject to submission of

Income and Assets certificate on a prescribed format issued by the competent authority and subject to verification of genuinity of the certificate by the issuing authority. As per DoP&T OM No. 36039/1/2019-Estt (Res), dated 31.01.2019, the crucial date for submitting income and asset certificate by the candidate is the date of interview, except in cases where date is fixed otherwise. Therefore, a valid EWS certificate will be the one which has been issued by the competent authority, as prescribed by the GOI/DOPT. Candidates who fail to produce valid EWS certificate will not be considered for reservation under this category. They will however, be considered for UR category. Therefore, EWS candidate must ensure that they have a valid EWS certificate on the date of interview. The EWS certificate must be valid for financial year 2023-2024 and issued on or after 01.04.2023 & on or before the last date of submission of application based on income of year 2022-2023.

Note: As per EWS guidelines, if vacancy earmarked for EWS cannot be filled up due to non-availability of a suitable candidate belonging to EWS, such vacancies for that particular recruitment year shall not be carried forward to the next recruitment year as backlog and these vacancies may be filled up as unreserved vacancies at the discretion of the selection committee.

### 9. METHOD OF RESOLVING TIES:

### 10. REASONS FOR REJECTION/CANCELLATION OF APPLICATION:

APPLICATION/CANDIDATURE OF APPLICANTS IS LIABLE TO BE CANCELLED/ REJECTED IN THE EVENT OF ALL OR ANY OF THE FOLLOWING:

- i. Applications being incomplete.
- ii. Any variation in the Signatures. All the SIGNATURE in FULL (NOT IN SHORT) done on the Application Form and also on other Documents must be the same.
- iii. Non-payment of application fees through Demand Draft, if not otherwise exempted.
- iv. Fee not paid as per instructions.
- v. Under-aged/over-aged candidates.
- vi. Failure to bring (in original) all relevant Certificates/Documents issued by the competent authority, along with self-attested legible copies in support of the information given in their Application Forms about their Educational Qualifications; Experiences; Percentage of Marks obtained; Proof of Age; Proof of Category [SC/ST/OBC/EWS/PwBD] at the time of Walk-in Interview and/or verification of document.
- vii. Not having the requisite Educational Qualification/Experience/Category Status as on 24.11.2023
- viii. Incorrect information or misrepresentation or suppression of material facts.
- x. Any other irregularity.

### 11. ACTION AGAINST CANDIDATES FOUND GUILTY OF MISCONDUCT:

- (A) Candidates are warned that they should not furnish any particulars that are false or suppress any material information while filling in the application form. Candidates are also warned that they should in no case attempt to alter or otherwise tamper with any entry in a document or the attested certified copy submitted by them nor should they submit a tampered/fabricated document. If there is any inaccuracy or any discrepancy, an explanation regarding this discrepancy should be submitted.
- (B) Without prejudice to criminal action/debarment up to 3 years from recruitment/examinations conducted by AIIMS, Patna wherever necessary, the candidature will be summarily canceled at any stage of the appointment in respect of candidates found to have indulged in any of the following activities:
  - i. Impersonate/ procuring impersonation by any person.
  - ii. Submitting fabricated documents or documents which have been tampered with.
  - iii. Making statements that are incorrect or false or suppressing material information.
  - iv. Resorting to any other irregular or improper means in connection with his/her candidature for the selection.
  - v. Misbehaving, Intimidating, or causing bodily harm to the officials employed by AIIMS, Patna during the 'Walk-in Interviews'.

- x. The selection of candidates for the post of Junior Resident will be subject to medical fitness. No selected candidate will be permitted to join the institute unless declared medically fit by the Medical Board appointed by the Institute. The decision of the Medical Board shall be final.
- xi. Private practice in any form during the course is prohibited. The period of training is strictly full-time and continuous.
