For Transfusion Medicine & Blood Bank candidates with MD degree in Transfusion Medicine will only be considered.

2. AGE LIMIT:

The upper age limit for applying these posts is 45 years.

Cut-off date to determine eligibility in terms of age of candidates will be the last date of submission of applications.

SC/ST/OBC/PWBD candidates who opt to apply for unreserved vacancies will not be eligible for age relaxation or relaxation in cut off marks which are otherwise allowed to those belonging to these categories. Further, reserve category candidates (SC/ST/OBC/PWBD) who become eligible by virtue of age relaxation applicable in their will be consider only for reserved seats of the category to which they belong even if they have the merit to be considered otherwise for UR.

Age relaxation is permissible to various applicants is as under: -

5. RESERVATION:

Date of issue of Certificate should not be earlier than 1 year from the last date of application from 05/09/2022 to 04/09/2023 (both dates inclusive). Candidate must submit the OBC certificate issued by the competent authority of Govt. of India in Format given by DOPT/Govt. of India or for the appointment to the Central Government Job.
- For EWS Candidates: Candidate(s) must attach certificate valid for the posts under the Central Government of India which mentions that the Candidates does belong to EWS category. Date of issue of Certificate should be from 01/04/2022 to 05/09/2023 (both dates inclusive).
