For Transfusion Medicine & Blood Bank candidates with MD degree in Transfusion Medicine will only be considered.

2. AGE LIMIT:

The upper age limit for applying these posts is 45 years.

Cut-off date to determine eligibility in terms of age of candidates will be the last date of submission of applications.

SC/ST/OBC/PWBD candidates who opt to apply for unreserved vacancies will not be eligible for age relaxation or relaxation in cut off marks which are otherwise allowed to those belonging to these categories. Further, reserve category candidates (SC/ST/OBC/PWBD) who become eligible by virtue of age relaxation applicable in their will be consider only for reserved seats of the category to which they belong even if they have the merit to be considered otherwise for UR.

Age relaxation is permissible to various applicants is as under: -

1. SC/ST- 5 years
2. OBC - 3 years
3. PWBD- 10 years
4. Ex Servicemen Candidate- 5 years.

3. APPLICATION FEES & MODE OF PAYMENT:

- General/OBC Category : Rs 1500/-
- SC/ST/EWS Category : Rs 1200/-
- Ex-servicemen/Women/PwBD candidate is exempted from any fee.

Application fee is required to be remitted through Demand Draft only. The **Demand Draft should be drawn in favour of AIIMS, Patna payable at AIIMS, Patna.** Any other instrument of payment is not acceptable. The application fee is non-refundable.

- a) For filling up of application on the date of walk-in interview, the candidates have to bring the following documents (**original and one set of self-attested copies**) which also needs to be produced at the time of walk-in interview:-

 - Category/PwBD Certificate (If seat is claimed in reserved category)

 - NOC from present employer (applicable for those working in Govt./Pvt. organization)
 - Demand Draft in original
 - Any other relevant documents (viz. Research Work, Publication etc.)
- b) The candidates are requested to fill the correct details regarding name/age/gender/caste/address/educational qualification and other relevant fields mentioned in the application form.
- c) Once form is submitted, there shall be no provision for making changes in the application form.
- d) Payment of application fees by any other mode viz. Cash, Cheque, Money Orders, Postal Orders, Pay Orders, Banker's Cheques, Postal Stamps, etc., will not be accepted. Such applications will be summarily rejected. The decision of Executive Director, AIIMS Patna in this regard shall be final and binding.

5. RESERVATION:

- The reservation for EWS/OBC-NCL/SC/ST candidates is as per Central Govt. rules and 5% for PwBD candidates (on horizontal basis).
- **For OBC-NCL Candidates:** Candidate(s) must attach certificate valid for the posts under the Central Government of India which mentions that the Candidates does not belong to Creamy Layer. Date of issue of Certificate should not be earlier than 1 year from the last date of application from **05/09/2022 to 04/09/2023 (both dates inclusive)**. Candidate must submit the OBC certificate issued by the competent authority of Govt. of India in Format given by DOPT/ Govt. of India or for the appointment to the Central Government Job.
- **For EWS Candidates:** Candidate(s) must attach certificate valid for the posts under the Central Government of India which mentions that the Candidates does belong to EWS category. Date of issue of Certificate should be from **01/04/2022 to 05/09/2023 (both dates inclusive)**.
*If no suitable candidate is found in the EWS Category during the selection process, the EWS seat may be converted to General Category.

- Eligibility is subject to verification of the documents on the day of Walk-in Interview.**

9. METHOD OF RESOLVING TIES:

All Tie cases (more than one candidate having same marks) have been resolved on date of birth. Older candidate (earlier date of birth) is ranked above younger candidate.

10. REASONS FOR REJECTION/CANCELLATION OF APPLICATION:

APPLICATION/CANDIDATURE OF APPLICANTS IS LIABLE TO BE CANCELLED/ REJECTED IN THE EVENT OF ALL OR ANY OF THE FOLLOWING:

- Non-payment of application fees through Demand Draft, if not otherwise exempted.
- Fee not paid as per instructions.
- Under aged/over aged candidates.
